1. Frame Uprights - Frame uprights are made from one-piece 1 1/4 x 1 1/4 metal tubing for strength.




2. Powder Coated Frame Uprights - Frame uprights are powder coated with Epoxy to prevent corrosion, flaking or scraping.




3. Front and Back Supported Frame Uprights -Frame uprights have two welded front to back supports for added stability.



4. Stabilizer - Metal stabilizer cross members are made from 18 gauge metal to ensure stability and added strength.







5. Casters - All casters are 3" swivel polyurethane braking caster.



6. Rails - Rails can be adjusted every 2 ½" on center (no tools required) allowing baskets to be adjusted in seconds flat.



7. Built in Stopper - Rails have a "Built-in" stopper to prevent the basket extending through the rear of the frame.



8. Height - Overall height of the frame is 77 $\frac{1}{2}$ " allowing them to fit through standard U.S. doors.







TERMS AND CONDITIONS

ACCEPTANCE

All orders are subject to acceptance of terms and conditions of sale, regardless of the form in which submitted. All orders are subject to price prevailing at date of shipment.

PAYMENT TERMS

Minimum order is \$50.00. Terms are net 30 days, FOB shipping point (subject to credit approval). Freight, taxes, handling and installation charges are not subject to discount. Credit Cards payments can be made if the total amount is \$5,000.00 or less.

SHIPMENTS

All shipment will be FOB shipping point. If goods are damaged when received, buyer must declare such damages at time of receipt of merchandise, directly on the shipping documents and claim must be filed within 24 hours with the transport company. If after the receipt of merchandise, concealed damage is discovered, buyer must notify delivering carrier requesting an inspection within 24 hours of discovery. The inspection report should be used to support buyer's claim against the carrier. Any claim for damage or shortage must be filed by the buyer with the delivering carrier. Unless a preferred routing is specified at the time of the order, shipment will be made by the best way, transportation prepaid and added to the invoice. For Collect and Third Party shipments, there will be an added 5% handling fee added to your order and the buyer will be fully responsible for all damages and claims.

RETURN POLICY

Merchandise will not be accepted for return unless specifically authorized by DSI, Inc. Products accepted will be subject to 25% restocking charge plus freight. This charge will be reduced to 10% with reorder. Returns must be shipped prepaid and returned within 15 days of the original receipt of shipment. Product must be returned in the original packaging. Items of special design, accessories and parts are not returnable. All goods returned damaged will not be accepted. The original purchaser must provide the following information:

- 1. Reason for return
- 2. Original purchase order and invoice from DSI
- 3. Model number and quantity to be returned

Any credit due customer from return of product will be given in the form of a credit memo that may be used against invoices currently outstanding or future product purchases. Cash credits will not be given, and credits must be used within 90 days from the credit memo date. Errors in processing by DSI, Inc. or defective merchandise are not subject to restocking charge.

LIMITED LIFETIME WARRANTY

All DSI products are backed by a limited lifetime warranty against defect of any kind. The warranty does not cover damage caused by misuse or damage caused by excess of manufacturer's recommended capabilities. All DSI products are guaranteed against defect to the original purchaser. Under this warranty, DSI's obligation is limited to repair or replacement of defective parts. This warranty does not include damage caused by misuse or damage caused by use in excess of recommended capabilities.




